

Terms and Conditions

Promoter: Sony Europe B.V., a company existing and organised under the laws of the Netherlands, registered with Dutch Registry under the number 71682147, with its registered office at The Heights, Brooklands, Weybridge, Surrey KT13 0XW ("**Sony**").

1. The Promotion entitles customers that have purchased one of the INZONE M10S products listed below ("**Qualifying Product(s)**") from any dealer within the EEA during the promotion period from Oct 14th 2024 until March 31st 2026 as well as customers who pre-ordered the Qualifying Products from Sept 24th 2024 onwards to claim a 12 months free Fnatic Plus membership subscription code worth 44 € ("**Voucher**") to redeem at Fnatic Ltd. (incorporated and registered in England and Wales with company number 07805670, whose registered office is at 1 Kingsland Passage, London, United Kingdom, E8 2BB). 8. Claims on the [Sony website](#) must be made online from thirty (30) days after the date of purchase and no later than 30th of April 2026, otherwise they will not be accepted.
9. You will be required to submit to the organizer (Sony) electronically the following with your claim form:
 - (1) a copy of the original sales receipt/invoice showing clearly the name of the retailer, date of purchase and the Qualifying Product name; and
 - (2) a picture of the serial number of your Qualifying Product displayed. To access the serial number this will be displayed on the packaging of the product or can also be found on the product.

Sony reserves the right to collect additional information and / or supporting documents to validate claims where necessary.
