- 1) This promotion (the "**Promotion**") is a consumer campaign and is available to consumers aged 18 or over, (hereafter referred to as "Participants") who have purchased a selected television (hereafter referred to as "**Promotional TVs**") in the period from 3rd December, 2024 to 7th January, 2025 inclusive ("**Promotion Period**") from selected [Sony Authorised Distributors](#) in the UK and Republic of Ireland and subsequently registered them with Sony in the period from 3rd December, 2024 to 1st March, 2025 inclusive ("**Registration Period**"). Customers must wait 34 days from the date of the qualifying Promotional TV purchase, to submit their claim with Sony in the period from 6th January to 1st March 2025 ("**Claim Period**"). Employees of Sony as well as commercial end customers/partners of Sony and their employees are excluded from participation. Claims from companies, organisations and institutions and claims from resellers as well as any claims from Sony employees, contractors or Sony's third-party service providers are excluded from this offer.
